## Approval of Agenda of July 11, 2024, Board Meeting

#### **Approval of Minutes of June 13, 2024, Board Meeting**

Commissioner Arter moved that the minutes of June 13, 2024, board meeting be approved as submitted. Commissioner Lee seconded the motion. MOTION PASSED UNANIMOUSLY (2-0).

#### Approval of Vouchers through July 11, 2024

Commissioners asked clarifying questions as appropriate. As of this date, July 11, 2024, the Board, by unanimous vote, does approve for payment voucher numbers 2024-07-02 through 2024-07-15 in the amount of \$45,804.84 for Accounts Payable of which four exceeded \$5,000 and \$2,576.00 for payroll. KPUD's Operation Director Dave Epperson gave an update on the operations portion of KPUD's Management of KCSD 7. Discussion ensued with guests participating.
